## Hutchinson Central Technical High School Student Responsibilities:

**As a student at Hutchinson Central Technical High School, I understand that I must meet certain responsibilities and obligations, including, but not limited to, the following:**

1. To remain on campus at all times during the school day as defined by my school program, **including lunchtime**. Students may leave the building **only** when picked up by a parent / legal guardian with Identification (in Infinite Campus).
2. To **arrive on time for all classes**. Absences and tardiness impact student performance. Detention and other consequences may be assigned for tardiness.
3. To **attend all my classes** excepting legally excused reasons (illness, bereavement, medical appointments, school field trips).
4. To refrain from unlawful use, possession or sale of drugs or alcohol **on or off** school grounds, when involved in any school activity, or when on the way to or home from school. I understand that violation of the District drug/alcohol policy will result in my suspension from school, notification of the Buffalo Police Department, and a parent conference.
5. To **dress appropriately for school**, recognizing that school is a public place of business and that I must honor the dress code. All clothing must cover undergarments.
6. To refrain from behavior that disrupts school activities and/or teaching and learning. I understand that actions such as inappropriate conduct – in classrooms, hallways, the cafeteria – such as profanity, insults, lack of respect for classmates and adults are unacceptable behaviors and may result in suspension.
7. To **use cell phones and other electronic devices in accordance with District policy**. Cell phones are off after leaving the cafeteria in the morning and stored in lockers. Cell phones are only used in classrooms at Teacher discretion. I understand that if I use my cell phone in any other way I must surrender it.
8. To refrain from using any type of recording device at school, with the understanding that taking pictures of other students or staff members with cameras or video recorders of any kind, including cell phones, without official permission is not only forbidden, but illegal. I understand that if I do so, my equipment may be confiscated and may result in suspension.

  10. To refrain from sexual harassment of others, whether verbal, written, or physical – including the use of social media. Any student found guilty of sexual harassment shall be subject to disciplinary action in accordance with the Code of Conduct.
  11. To **respect the dignity of all** members of our Tech family. I understand that racial, ethnic, sexist, threatening, or other inappropriate comments or actions will result in immediate disciplinary action.
  12. To refrain from any type of bullying or hazing activities, including electronic bullying, that would be likely to cause physical or emotional harm. Any student involved in bullying or hazing will be subject to suspension and may be referred to the Buffalo Police Department.
  13. **Seniors must maintain good attendance and grades** to fully participate in Senior Activities and will be required to sign a separate contract.
  14. **To serve all assigned detentions. I understand that not serving detentions will result in suspension.**
